Warranty Conditions

- All warranty considerations apply for original retail purchaser only

ActionKover Fiberglass Tonneau Cover 3 Year Limited Warranty

ActionKover warrants to you, the original retail purchaser of an ActionKover brand fiberglass truck cover, that the body will be structurally free from defects in material and workmanship for three (3) years. The body includes the fiberglass shell and mounting rails only. ActionKover warrants to you, the original purchaser, for three (3) years that the exterior paint will not abnormally fade or peel due to material or workmanship defect faster than the original pickup it was installed on. Due to truck manufacturer variance, exact color match is not guaranteed. Locks are warranted for one (1) year from your retail date of purchase against failure due to defects in material and workmanship.

Hardware

All hardware, including locks, props, and brackets hardware are warranted for one (1) year from your purchase date, from failure due to defects in material or workmanship.

THERE ARE NO OTHER WARRANTIES, EXPRESSED OR IMPLIED, INCLUDING, WITHOUT LIMITATION, ANY IMPLIED WARRANTY OF MERCHANTABILITY OR IMPLIED WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE. ANY SUCH WARRANTIES ARE DISCLAIMED. THIS WRITTEN WARRANTY IS THE SOLE AND EXCLUSIVE REMEDY PROVIDED FOR THE ACTIONKOVER.

EXCEPT FOR AS SPECIFICALLY PROVIDED IN THIS LIMITED WARRANTY, ACTIONKOVER SHALL NOT BE RESPONSIBLE FOR DIRECT DAMAGES AND UNDER NO CIRCUMSTANCES SHALL ACTIONKOVER BE RESPONSIBLE FOR ANY INDIRECT, SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES due to installation, use, misuse, abuse, neglect, or otherwise regarding any ActionKover product. Some states do not allow the exclusion or limitation of incidental or consequential damages, so this limitation or exclusion may not apply to you.

Exclusions

Not covered under this warranty is structural failure due to neglect, alterations, addition of equipment, abuse, accident, use in competitive racing or vibrations from worn or altered truck suspensions or sound equipment.

Stress crack(s) caused from misuse, abuse, collision or competitive racing are

excluded. If a stress crack occurs it should be repaired without delay to prevent future failures due to neglect.

Stress cracks in the exterior finish caused by impact are not covered under warranty. A stress crack caused by impact from the inside has the appearance of a "star" on the outside surface. A stress crack caused by impact to the outside will cause circular stress cracks. Both stress cracks radiate from a center point(s) of impact. A mark may or may not be visible at the point of impact.

Consequential damage or loss due to the installation, use, misuse, abuse or neglect is the sole responsibility of the pickup owner and operator. Paint wear to your truck's bed is normal and is expected with the installation and the use of any truck cover and is the sole responsibility of the pickup owner. Precautions should be taken by the pickup owner to prevent corrosion. ActionKover shall not be held liable for any consequential loss or damages arising from the purchase, installation or use of these products.

No implied warranty or fitness for a particular purpose, if any, shall extend for a longer duration than the terms of this written warranty.

Warranty Claims

In the event of a warranted product failure it is ActionKover's discretion to repair or replace the defective part(s). ActionKover reserves the right to replace any parts with current production parts of equal or greater quality and value. All claims must be made to the ActionKover retailer from which you purchased your ActionKover. If you have relocated and/or are unable to return to the ActionKover retailer where you made your purchase, visit www.actionkover.com for the nearest ActionKover Retailer. The ActionKover Retailer will process your claim and make the necessary repairs or replacements. Personal identification along with proof of purchase and ownership of the original pickup and ActionKover are required for all warranty claims.
